1. 遴選會員

凡持有證監會牌照之註冊人仕,同時受僱於獲證監會發牌經營證券及期貨條例附表 6 所列第 1, 2, 4, 5, 6, 8 或 9 項 受規管業務之法團,並且須獲得該法團的推薦,均可依章申請為遴選會員。

Voting Member

A person is eligible to become a Voting Member if he is a person licensed by the SFC and he is employed by a licensed corporation carrying on business under types 1, 2, 4, 5, 6, 8 or 9 of the regulated activities described under Schedule 6 of the SFO and he is nominated by that corporation to apply to become a Voting Member.

2. 基本會員

凡持有證監會持牌法團代表牌照,並從事根據證券及期貨條例附表 6 所列第 1, 2, 4, 5, 6, 8 或 9 項受規管業務之人 仕,均可依章申請為基本會員。

Ordinary Member

A person is eligible to become an Ordinary Member if he is a licensed representative licensed by the SFC in respect of types 1, 2, 4, 5, 6, 8 or 9 of the regulated activities described under Schedule 6 of the SFO.

3. 附屬會員

凡受僱於獲證監會發牌經營證券及期貨條例附表 6 所列第 1 至 9 項任何受規管業務;或該人仕屬與證券行業有關的專業團體之會員,如會計或法律等專業,均可依章申請為附屬會員。

Associate Member

A person is eligible to become an Associate Member if he is in the employment of a corporation licensed by the SFC under any type 1 to 9, inclusive, of the regulated activities described under Schedule 6 of the SFO, or if he is a member of a professional body related to the securities industry such as the accounting or legal profession.
