# 申請須知

## General Information

### 會籍類別

#### Membership Categories

#### 1. 遴選會員

凡持有證監會牌照之註冊人仕，同時受僱於獲證監會發牌經營證券及期貨條例任何一項受規管業務之法團，並且須獲得該法團的推薦，均可依章申請為遴選會員。

##### Voting Member

A person is eligible to become a Voting Member if he is a person licensed by the SFC and he is employed by a licensed corporation carrying on business under any one type of the regulated activities described under the SFO and he is nominated by that corporation to apply to become a Voting Member.

#### 2. 基本會員

凡持有證監會持牌法團代表牌照，並從事根據證券及期貨條例任何一項受規管業務之人仕，均可依章申請為基本會員。

##### Ordinary Member

A person is eligible to become an Ordinary Member if he is a licensed representative licensed by the SFC in respect of any one type of the regulated activities described under the SFO.

#### 3. 附屬會員

凡受僱於獲證監會發牌經營證券及期貨條例所列的任何一項受規管業務；或該人仕因以下原因而被董事會認為有資格成為會員，均可依章申請為附屬會員，包括但不限於：-

- (a) 如果與證券行業有關的專業團體之會員，例如會計或法律專業的成員；
- (b) 如果畢業於或就讀於金融、商業或其他相關學科的大專院校或大學；
- (c) 如果他目前失業，但因為以前的工作有資格成為會員；或者
- (d) 如果他是退休人仕，並且本來有資格成為會員。

##### Associate Member

A person is eligible to become an Associate Member if he is in the employment of a corporation licensed by the SFC under any one type of the regulated activities described under the SFO, or if he is considered to be so eligible by the Board for reasons that his background is related to the objects of the Association, including, without limitation:-

- (a) if he is a member of a professional body related to the securities industry such as the accounting or legal profession;
- (b) if he is a graduate of or is enrolled in a tertiary institution or university majoring in finance, business or other related subjects;
- (c) if he is currently unemployed but would have been eligible to become a Member while he was in his previous employment; or
- (d) if he is a retiree and would have been eligible to become a Member but for his retirement.

附註：

祇有遴選會員享有投票權，並可於董事會上動議決議案及合資格參選為本協會董事。除此之外，遴選會員、基本會員及附屬會員均可享有相同之權利、優惠及義務。

Remarks:

Only Voting Members shall have the right to vote and propose resolutions at a general meeting and be eligible to stand to be elected as a Director of the Association. The rights, privileges and obligations of Voting Members, Ordinary Members and Associate Members shall be the same in all other respects.
